RE: **Interest Rate on Judgments or Decrees Effective January 1, 2022**

---

Section 55.03 (1), Florida Statutes, requires the Chief Financial Officer of the State of Florida to set the interest rate payable on judgments or decrees quarterly.

Please be advised that the interest rate for the quarter beginning January 1, 2022 remains unchanged at 4.25% per annum or .000116438 per day.

Pursuant to § 215.422 (13), Florida Statutes, the interest rate for payments to health care providers remains at 1% per month or a daily rate of .0003333.
