Important Notice from the Clerk of Court

To all Criminal and Juvenile Delinquency Practitioners:

In response to the passage of the crime victim rights constitutional amendment, commonly known as Marsy's Law, the Florida Supreme Court released SC20-1128, In Re: Amendments to the Florida Rule of General Practice and Judicial Administration, on Thursday, November 18, 2021, adopting new Rule 2.423 (FRGP&JA). You can view the opinion here: <u>SC20-1128</u>, *In re: Amendments to Florida Rule of General Practice and Judicial Administration 2.423*.

The new Rule provides that filers of court documents shall limit the presence of crime victim identifying information in accordance with rule 2.425(a)(3) or <u>file a "Notice" with each court filing that</u> <u>contains confidential crime victim information</u> when Marsy's law has been invoked.. A crime victim, the filer, a party, or any affected nonparty may file a "Notice" of Confidential Crime Victim Information within Court Filing" at any time. The Notice shall identify the precise location of the confidential information within the document being filed.

Please note that the Clerk of Court does NOT have authority to redact or protect victim information in court filings if this Notice is not filed. If a "Notice" is filed, the clerk of court shall review the filing identified as containing confidential crime victim information to determine whether the purported confidential information is facially subject to confidentiality. However, the Notice is not required when an entire case file is maintained as confidential.

Once a Notice is filed, if the clerk determines that the information is not confidential, the clerk shall notify the filer in writing within 5 days of filing the notice and thereafter shall maintain the information as confidential for 10 days from the date such notification by the clerk is served. The information shall not be held as confidential for more than that 10-day period unless a motion has been filed pursuant to rule 2.420(d)(3).
