Community Legal Services is need of mentors for our Family Law Peer Academy. The Peer Academy is a comprehensive, peer focused, training program, which allows CLS to meet emerging client needs while training pro bono attorneys in subject matter areas that are needed for the community we serve and allows the pro bono attorney to build a paying practice out of.

Mentors will support one or two participants throughout the course of the Peer Academy. 




