#### **RESPONSIBILITIES:**

- 1. Manage financial matters related to VCBA including banking, budget preparation, expense review, and submission of tax reports, execute various financial responsibilities including making deposits and paying outstanding bills, utilizing QuickBooks, and submitting tax reports to President, Treasurer and CPA.
- 2. Oversee all aspects of programs, services, and events, including marketing, registration, and event coordination.
- 3. Coordinate and facilitate board meetings, regular membership, section meetings and ensuring proper documentation and communication with board members.
- 4. Oversee the planning and execution of Continuing Legal Education (CLE) seminars, including topics, speakers, and logistics.
- 5. Curate and publish a monthly newsletter to keep members informed and engaged.
- 6. Manage and update the organization's website to ensure it remains current.
- 7. Prepare and administer annual VCBA and YLD board elections.
- 8. Handle lawyer referral requests from the public seeking a private practice attorney. Refer requests for a pro bono attorneys Community Legal Services.
- 9. Schedule occasional one-on-one meetings with past Presidents, including those on the bench, to encourage ongoing involvement and gather feedback.
- 10. Provide periodic project updates to the Chief Judge to highlight the bar's support for the legal community.
- 11. Attend the Florida Bar Leader's Conference and the American Bar Association Small Bar to network, gather new ideas, and seek support from similar-sized bar associations.
- 12. Maintain communication with vendors (e.g., printer, banquet managers) and explore potential sponsors for upcoming bar events.
- 13. Prepare and administer a social media strategy including maintenance and regular communications.
- 14. Retain an updated membership roster, prepare dues notices, and collect payments from members.
- 15. Other duties as assigned.
