Computer Resources in the Courthouse Law Libraries also include:

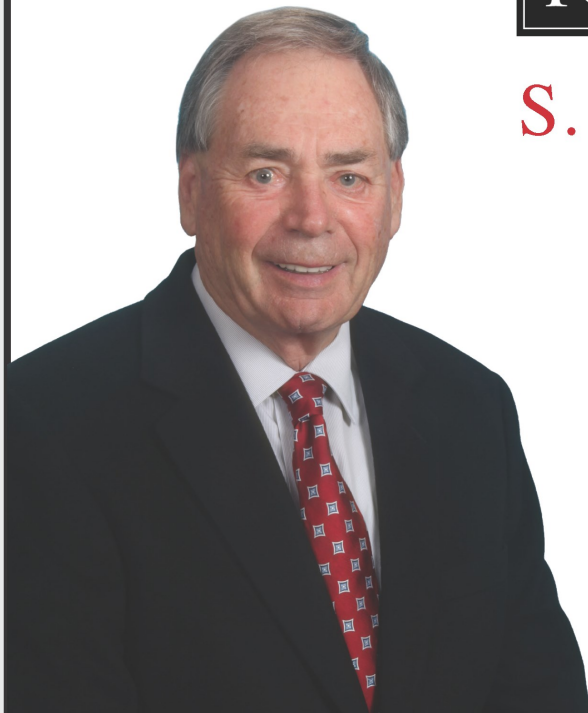
