Judge Bryan Feigenbaum



Practice area: I was a prosecutor for 20 years, 1990-2010. I handled all kinds of cases here in the 7th Judicial Circuit. I was appointed to the Bench in 2010. Spent the first two and a half years in a civil division, handling cases in Daytona Beach, New Smyrna Beach, and DeLand. Shortly after getting elected in 2012, was assigned to a criminal division at City Island. I handle that division and a Veterans Court that meets twice a month. I cover other divisions, county and circuit, whenever I can.

Where were you born and where did you grow up? I was born in Baltimore, Maryland in 1965. 

Civil Traffic Infraction Hearing Officer

The Seventh Judicial Circuit Court is accepting applications from attorneys interested in serving as Civil Traffic Infraction Hearing Officers in Flagler, Putnam, St. Johns & Volusia counties (see Rule 6.630, Florida Traffic Court Rules; §§ 318.30-318.38, Florida Statutes; and Article V, Section 1, Florida Constitution). In order to be considered, an attorney must:

- (a) be a member in good standing of The Florida Bar;
- (b) be familiar with pertinent provisions of Florida Statutes and Florida Rules of Traffic Court;
- (c) abide by The Florida Bar Code of Professional Responsibility and applicable provisions of the Code of Judicial Conduct;
- (d) undergo a background screening to include reference and criminal history checks; and
- (e) complete an initial 40-hour training program prior to serving and agree to obtain 4 hours of continuing education annually thereafter.

In accordance with opinions issued by the Florida Supreme Court's Judicial Ethics Advisory Committee, Civil Traffic Infraction Hearing Officers are prohibited from representing clients in civil traffic and criminal traffic matters.

Applicants must be willing to travel to Bunnell, Daytona Beach, DeLand, Palatka, South Daytona and/or St. Augustine. Civil Traffic Infraction Hearing Officers are independent contractors. Compensation is approximately \$65 per hour.


