
YLD FOOD BRINGS HOPE FRESH MARKET VOLUNTEER EVENT

Anderson, Bonamo re-elected to The Florida Bar board of governors

In elections for The Florida Bar's leadership, 15 incumbent members of the board of governors were re-elected to additional two-year terms without opposition, including Geddes Anderson in the 4th Judicial Circuit and **Philip Bonamo in the 7th Judicial Circuit**.

Board of governors members Paige Greenlee of Tampa and Jeff Rynor of Miami Beach qualified as candidates for Florida Bar president-elect in the Bar's 2026 elections.

Voting begins March 1, 2026. Ballots must be received before midnight March 15, 2026. Any runoff elections will be conducted in April

Gov. Ron DeSantis announces five judicial appointments December 22.


Judge Katherine H. Miller of Daytona Beach to serve as judge on the Seventh Judicial Circuit Court



RE: **Interest Rate on Judgments or Decrees Effective January 1, 2026**

Section 55.03(1), Florida Statutes, requires the Chief Financial Officer of the State of Florida to set the interest rate payable on judgments or decrees quarterly.

Please be advised that the interest rate for the quarter beginning January 1, 2026, has been reduced to 8.44% per annum or .0231233 % per day.

Pursuant to section 215.422(13), Florida Statutes, the interest rate for payments to health care providers remains at 1% per month.


